IX. Conclusion of "Walk the Halls" Reports, "Meet and Greet" debriefing and assessment

XI. New Business

A. Chair Warren called a vote for support of AB 1335 (Maienschein): Increase in penalty for sex crimes committed against persons with disabilities. R. Shontz, L. Sullivan, A. Warren, M. LePeilbet, J. Kim-Selby, M. Gould, and E. Wolf in favor of supporting bill. S.A. G. Richards opposed. Motion carried, CSL office will write a letter of support.
