Don't forget! When you do your taxes or help somebody else do theirs, remember Code 402 on the California State Income Tax Return. Also, tell all your friends and family!

#### **More Census Information**

According to the U.S. Census Bureau there are 10 questions that MUST BE FILLED OUT, and no more.

- 1. How many people were living or staying in this house, apartment or mobile home on April 1, 2010?
- 2. Were there any additional people staying here April 1, 2010 that you did not include in question 1?
- 3. Is this house, apartment, or mobile home? (Owned, rented, leased, or lived in rent free?)
- 4. What is your phone number (including area code)?
- 5. Please provide information for each person living here, starting with person living here or rents, (starting with #1).
- 6. What is person #1's sex? (Mark one box)
- 7. What is person 1's age and what is person 1's date of birth?
- 8. Is person 1 of Hispanic, Latino or Spanish origin?
- 9. What is person 1's race" (Mark 1 or more boxes).
- 10. Does person 1 sometimes live or stay somewhere else?

According to the Census Bureau, all forms will be mailed out first. If the form you received is not filled out completely, truthfully, or you do not fill it out at all, a list will be given by the U.S. Census Bureau to a Census taker who will then come to your house and fill out the form with you. If you refuse to cooperate with the person who has to come to your house the first fine will be \$500.00. They can come with an officer of the law and arrest you if you refuse to co-operate with the Census Bureau or Census taker. You can go on-line and thoroughly read every page written by the Census Bureau. As much as you may think this is a total invasion of privacy, it looks like we have no choice but to fill the thing out.
