**CODE 402**: I want to wish every CSL member a "Happy Holiday Season"! Our Code 402 contributions as of the end of October stands at \$279,391. As you know we must raise a minimum of \$250,000 to stay on the Franchise Tax Board voluntary contributions list. Keep promoting Code 402 to get those late tax payers to contribute to the California Fund for Senior Citizens.

TRAVEL EXPENSE **CLAIMS** (TEC): If you are like me, you probably have not received reimbursement for attending the Annual Session. This has created a hardship on many of our dedimembers. cated CSL After conferring with the Department of General Services Accounting, I discovered the TECs were not paid until the budget was signed and then "vendor" payments were made first because they have priority over TEC payments. I erroneously thought our staff was not processing our claims in a timely manner when, in fact, State representatives indicated they can only process a few TEC reports at a time. My recommendation is that CSL increase the credit limits on our American Express Card and use this card for all room expenditures in the future. Your suggestions are also appreciated.

**CONSULTING EXECUTIVE DIRECTOR:** Senior Senator Joe Cox, Senior Senator Lola Young, and I interviewed the selected candidates for the CSL Consulting Executive Director position. ### New Top 10 State Proposals

#### **AP-34 SB-33** (Simitian/Wolk)

Senior Assembly Member Shirley Krohn Elder and Dependent Adult Abuse (First Proposal to be authored)

#### AP-11 Senior Assembly Member Shontz:

**Identity Theft Fines.** This proposal establishes definite minimum fines for identity theft of \$5,000 for first offense and additional \$3,000 for each additional offense.

#### AP-4 Assembly Member Tucker: Elder Abuse

Fines. This proposal increases elder abuse fines by 10% and transfers the additional funds to local entities for combating elder abuse.

#### **AP-25 Senior Assembly Member Lucero:**

Hearing Aid Availability and Cost. This proposal requires that hearing aids be made available for over-the counter sales and vendors be encouraged to submit a plan to the Hearing Aid Dispensers Bureau.

#### SP-16 Senior Senator Eaton: Property Tax

**Exemptions.** This proposal increases the homeowner's property tax exemption from \$7,000 to \$27,000 for seniors.

#### AP-13 Senior Assembly Member Rolfe: Income Tax Mileage Deduction. This proposal authorizes an income tax deduction for mileage equal to the difference between the Federal volunteer mileage deduction and the Federal business mileage deduction.

AP-32 Senior Assembly Member Krohn: Independent Long-Term Care Ombudsman Office. This proposal establishes an independent LTC Ombudsman Office within a private nonprofit organization.

#### AP-7 Senior Assembly Member Sorenson:

Prescription Purpose. This proposal requires the prescriber of medication to include the condition or purpose of the drug on the label.

AP-21 Senior Assembly Member Molnar: Senior Citizens Property Tax Deferral Program. This proposal rescinds the indefinite suspension of the senior citizens property tax deferral program to allow claimants to claim to postpone ad valorem property taxes under the Senior Citizens Property Tax Postponement Law.

### AP-43 Senior Assembly Member Bloch: Disaster

**Emergency Transportation for Disabled and** Senior Citizens. This proposal mobilizes paratransit, paramedics, and others to move disabled and seniors to safe places in the event of natural disasters.

### **New Top 4 Federal Proposals**

AFP-2 Senior Assembly Member Weintraub: Medicare Coverage of Dental Care and Hearing and Visual Aids. This proposal expands Medicare coverage to include dental care and dental plates; hearing aids; and vision aids, including eyeglasses and contact lenses.

#### SFP-1 Senior Senator Steir: Public Housing for

Senior Veterans. This proposal requires that preference for public housing be given to eligible seniors who are honorably discharged veterans.

#### SFP-5 Senior Senator Hartmann: Tire Safety Identification. This proposal requires tire manufacturers to clearly label tires with month and year of manufacture and include the info on sales receipts.

SFP-6 Senior Senator Eaton: Social Security and Medicare Sustainable Program Costs. This proposal requires the enactment of legislation addressing the solvency of the Social Security and Medicare program trust funds so that program costs are sustainable.
