IX. Review of previous "Walking the Halls"

The Legislative Committee members and alternates walked the halls of the Capitol Building in April 2008. Everyone agreed that it was a good idea to include the alternates to give them an idea of what is expected. Many positive comments were made regarding last year's "Walk the Halls."

X. Review of Teams

It was discussed that there are too many alternate vacancies on both the Legislative and the Joint Rules Committees and the chairs agreed to work on finding more members.

The list of state legislators stayed the same as last time for most of the teams with a few differences. Chair Mack encouraged members to stop by and greet their representatives even if they were not on their list.

Chair Mack suggested that proposals which don't involve money should be pointed out and she advised that each member needs to be familiar with all the top 20 state and the top eight federal proposals.

Discussion took place over how to publicize the need for the Ombudsman and Senior Legal Hotline throughout the state. If letters are sent supporting these issues, copies should be sent to the CSL office as well.

XI. How to Talk to Your Legislators Workshop

Tom Riley from the Cal Capitol Group led a "How to Talk to Your Legislators Workshop" workshop. He announced that, for the most part, the state Legislators have a good feeling towards the CSL.

The worst thing would be for our proposals not to have any authors.

The second worse thing would be for there to be two or more authors for the same proposal which could cause friction.

Mr. Riley suggested that the CSL members give a deadline of January 15 to the state Legislators to get back to the CSL office on which proposals they are interested in and CSL should contact them if they haven't contacted the office by a week after the deadline.

There a lot of new legislators this year who are still getting used to how things are done so it was suggested that CSL members be open to possibly presenting the same issue in different ways.

In teams of two, one person should be designated ahead of time to be the note taker and be sure to hand business cards out when first introducing yourself. When shaking hands and introducing yourself, be sure to look the other person in the eyes. Before handing them a packet, pull out the priority book and point out three or four proposals that you think they would like to author.

If there isn't anybody that speak to you right then, suggest you can come back in an hour or so and then come back. Make sure if you state you'll only take up 12 or 15 minutes of their time, you start your leave taking at that time.
