He pointed out that even "good bills" have opposition so you need to understand where the

opposition is coming from and try to find a compromise if possible. Mr. Riley suggested teaming with other organizations as much as possible to get a bill through the system. People and organizations who might be your enemy now can be your friend in another issue.

Mr. Riley went over the process a bill goes through to become a law and he mentioned that the most important thing is to advocate for that bill. You need to keep in contact with the state legislator's, who is authoring the bill, staff members so you will know how they feel about it.

Don't forget to look straight into the eyes of the person you are introducing yourself to without looking away and remember to be respectful of ALL staff members, including the receptionist/secretary/intern. What you discuss before and after the meeting may be as important as what is discussed during the meeting.
