V. Review Legislative Section of Resource Manual Correcting/adding/deletions

Part II, page 1,sixth paragraph, replace "...ten members are elected..." with "...five Assembly Members are elected in odd-numbered years for a two-year term in both the CSL Joint Rules Committee (JRC) and the Legislative Committee." Add "Five members of the Senate are elected in even-numbered years for a two-year term in both the CSL JRC and the Legislative Committee." Add to last sentence "...and the Legislative Committee meets no less than four times annually."

Part II, page 7, last sentence, change "corporation" to "cooperation."

Part III, page 1, delete Article III, Section I and adjust the rest of the Article numbers.

Part III, page 4, Article VIII, Section I, replace "appointed aides" with "alternates." Part III, page 12, Section 2, No. g, replace sentence with, "Monitor the progress of legislation and provide ongoing status reports and legislative alerts to the Legislative Committee, the JRC, and members of the CSL."

Part IV, page 1, fourth bullet, replace "shall select a specific day of the week to be available" with "should be available as needed."

Part IV, page 2, No. 14, replace "in May" with "each fiscal year."

Part IV. page 3, Facts: 1., delete "January 22nd", the parenthesis, and the word "or." Process: replace existing 1. with "Each member of the Legislative

Committee shall be available as needed to testify in Sacramento." Delete 2. and 3. Change 4 to 2., delete "With a limited budget now and in the foreseeable future, no overnight." Add "....will not be reimbursed...."

Part IV, page 7, No. 2, add "and posted on the CSL website," between Book and at least.

Part IV, page 17, first paragraph, change "lobbying" to "advocating."

Part IV, page 18, first paragraph, change "lobbying" to "advocating."

Part IV, page 24, No. 15, change phone number to say "the CSL office."

Part IV, page 29, Review Process: No. 1, change "Policy and Procedures" to "Legislative."

Part IV, page 29, No. 9, add "....shall be reviewed by the Legislative Committee and/or the Executive Committee...."
