- B. The committee discussed the best start time for future meetings. It was agreed that future meetings would begin at 1pm. Early arrival requests must be approved by Don MacAllister w/ copy to Julia Rosenberg and the office.
- C. Chair Rosenberg requested members email the office with their flight choices and hotel requirements at least two weeks in advance.
- D. Chair, Julia Rosenberg noted that it is the Legislative Committee primary members' responsibility to notify their alternate if they can not make a meeting with as much advance notice as possible.

## IX. "Walk the Halls" de-briefing and sharing insights

- A. Teams provided short debrief and shared insights. The following bills were presented for vote of CSL support and were unanimously approved for support letters to be sent.
  - 1. AB 1224 Veterans' Farm and Home Purchases Employment Training Panel (P. Cook)
  - 2. AB 1225 Cemeteries: Veteran's Commemorative Property (P. Cook)
  - 3. SB 1198 Homeless Veterans (R. Calderon)
  - 4. SB 1258 Department of Veterans Affairs: Monitoring Outcomes for Veterans(L. Wolk and L. Correa)
  - 5. SB 1170 Senior Insurance (M. Leno)
  - 6. AB 1714 In Home Supportive Services: Providers (L.Halderman)
- B. Senior Senator Lola Young suggested that someone keep track of veteran bills, so that CSL can maintain active on all vet bills. Senior Assemblymember Julia Rosenberg requested Senior

- Senator Lola Young to keep track of veteran bills and communicate to Senior Assemblymember Charles Mitchell.
- C. Senior Assemblymember Marcia Gould will send AB 1422 for the group to review and follow-up regarding the possibility of support.
- D. Senior Senator Nneenah Frazier noted that SB 1400 Residential Care Facilities for the Elderly has been pulled and is being handled as an administrative issue. Senior Senator, Lola Young suggested that it be followed-up on to ensure that it doesn't "die". Senior Senator Frazier will continue follow-up.
- E. Senior Assemblymember Richard Shontz provided an overview of AB 2374 Consumer Credit Reports. Assemblymember Shontz plans to write a letter to the chairman and committee members individually in support of this bill.
- F. Senior Assemblymember Marcia Gould indicated that she had an article from AARP titled "Are You Missing Out on Benefits?" She stated that it references where seniors can go on the internet for help. It was requested that the office send this out to the membership or link it in the newsletter. It was noted that the information is copy written.
- G. Senior Assemblymember Marcia Gould recapped her 2004 proposal which required the purpose of the medication to be included on the drug label. She is presenting this proposal again and knows that the Medical Association will fight it but it hopes to gain support from the Pharmaceutical Association. She passed around a medication form w/ CSL logo that can be utilized in the session program book. Chair Julia Rosenberg will present this form to the JRC for review/discussion. Assemblymember Gould requested that anyone with a pharmaceutical contact to please contact her. Additionally, she provided a form for Kaiser Members to show support.
- H. Copies of Senior Senator Lola Young's thank you notes were distributed as samples to the committee.
- I. Senior Assemblymember Allan Hurst discussed the need for a bill to "unbundle" homeowner and auto insurance when seniors no longer drive to avoid an increase in insurance cost.
- J. Senior Assemblymember Charles Molnar spent time trying to save AB 1525 Elder or dependent adult financial abuse: mandated reporters. Assemblymember Molnar reported that the District Attorney of San Diego will co-sponsor the bill.
