MacLaughlin gave tips and advice for working with CA legislators, and stressed the importance of looking at individual area issues as well as elections and outcomes:

1. This year is an election year; look at election details in each area. Legislators that are in tight races are good candidates to approach for support/sponsorship of CSL proposals in order to appeal to their senior constituents when running for re-election.

2. California's seniors are a demographic for upcoming elections that every member of the legislature is trying to court right now; exploit this for the next 6-8 months!

3. Be flexible, and willing to work with legislators on proposals and any changes. Compromise is the name of the game when it comes to working together with legislators.

4. Encouraged CSL members to introduce themselves to members of organizations that are also working on pertinent senior issues in California.

5. Appeal to legislators on the hot button issues for elders in CA right now such as assisted living, elder access to healthcare, secure housing, and mobility
