We will be having a four-day session this year, and I cannot emphasize enough the fact that our members worked hard to exceed the minimum amount for the FTB and that is the reason the four-days are possible. Whether we can continue to have a four-day session will depend on each of us to continue in our efforts to promote CODE 402.
