X. Legislative Committee Report – Chair Senior Senator Anne Mack

The priority proposal book is being proofed and the list is being organized of which CSL member will visit which state legislator. New CSL members and new state legislators make the list a little more complicated but the basic list will stay the same as last year as much as possible.

All proposals must be in the CSL office by June 1, 2009, with no exceptions, or will not be accepted due to the timeline of putting proposals into legal language, the proposal book, getting it printed and distributed to the CSL members to study before the October Session.

The November "Hey, CSL, What's Up" listed some of the new Legislative Committee wrong. From Health Committee Senior Senator Bruce Steir's alternate is Senior Senator Horace Mann. From Housing and Transportation Committee Senior Senator Lenwood Long is the primary with Senior Senator Bill Young as the alternate.

Chair Mack distributed sample letters to be sent to the Governor advocating for the Ombudsman Program to be reinstated. The same letters can be redone for the Senior Hotline Funding.

Several of the new proposals are already being reviewed by various state legislators and the October 23 Press Advisory was emailed to all ongoing state legislators.

2009 Code 402 campaign immediately. Senior Senator Erman has been asked to continue as our representative on the CheckOff California campaign. It is important that the CSL has consistency in their representation with this endeavor. A proposal for Public Relations was passed out. Because it relates to Public Relations and Fund Development and involves a large sum of money, the Public Relations, Fund Development, and Budget and Finance Sub-Committees have been asked to review this proposal and provide a recommendation at the next JRC meeting.

Copies of the November 18, 2008 *Senior Spectrum* was passed out. This issue has made the CSL Session results their front page article.
