Admirers called Leo Tarcisius McCarthy the "Lion with a heart." In the mid- to late-1970s, he served as Speaker of the Assembly and later served an unprecedented 12-year term as California's Lieutenant Governor.

McCarthy's interest in the field of aging began in early 1963 when then Gov. Edmund G. "Pat" Brown appointed him to the California Commission on Aging. No matter what titles he held throughout his career, he spent his life exploring issues related to the elderly, human rights and justice and introducing and implementing initiatives that would benefit all Californians. At his passing, he still served as a member of the Board of Directors for the California Advocates for Nursing Home Reform (CANHR, 1991-2007).

As Speaker of the Assembly, McCarthy created the Assembly Standing Committee on Aging, making California only the second state in the nation to create an ongoing committee to deal with issues of aging. He felt strongly these issues needed to be included on the list of top legislative concerns

for California. McCarthy appointed then Assemblyman Henry Mello to serve as the Aging Committee's first chairman.

Together, Mello and McCarthy initiated and supported the concept of a California Senior Legislature, charged with identifying problems of the elderly throughout the state's aging network and submitting them as proposals to be taken up by the State Legislature. Mello was referred to as the "Father" of the CSL – McCarthy was often referred to the "Godfather" of the CSL. Their interest and support for the CSL continued throughout their lives.

McCarthy was born in Auckland, New Zealand in 1930. He immigrated to San Francisco with his parents and older brothers at the age of 4. McCarthy's legacy remains in the laws he initiated and in through the careers of people he mentored and followed him into the field of politics. Three of them include former Assemblyman Art Agnos, Congresswoman Anna Eschoo and Speaker of the House, Nancy Pelosi. They were also his long-time friends.

McCarthy is survived by his wife Jacqueline, daughters Conna McCarthy and Sharon Allen, sons Adam and Niall McCarthy, and 11 grandchildren. At the time of his death, McCarthy was memorialized by media throughout the state as an "incredible political leader" and "a good guy." The CSL is truly privileged to have had him as a friend.
